Additional time may be reserved the date of the event. The hourly charge for this additional time is **\$100.00** per hour payable at the conclusion of the event. ***Deposit is non-refundable and is due when contract is signed to reserve the date.**

General Requirements:

1. The customer must provide power for the DJ within 25 feet of the set-up location.
2. The DJ service reserves the right to cancel a scheduled performance once commenced if an event beyond control of the DJ service occurs. If the event is outdoors, then the customer must allow the DJ service to move inside or provide suitable covering (i.e. shelter from rain/direct sunlight) for the DJ service's equipment. In the event the customer does not do so, the DJ service may, at their sole discretion, terminate their performance and no refund will be given to the customer.
3. Big Beat DJ Service reserves the right to charge an additional fee if it becomes necessary to move their equipment from one location to another during any single event (unless agreed upon before the date of the event).
4. The customer will use efforts to keep the spectators or crowd participants within reasonable limits of behavior.
5. This agreement guarantees the attendance of the owner or an employee of Big Beat DJ Service at the above-stated function, unless otherwise specified.
6. In case of cancellation by the customer, the full balance will be due immediately unless the DJ Service is provided with a minimum 90-day notice. The customer will be liable for any legal expenses incurred by the DJ Service in obtaining the full balance due. Every attempt will be made by the DJ Service to re-book the date. If the DJ Service is successful in doing so, the customer, who originally booked the date, will be refunded the full amount minus the deposit.
